



## Discounts

**Sisters:** There is a \$250 tuition discount for the second and each additional sister enrolled in a 4 or 8 week session.

## Non-refundable Fees for Withdrawals

**Tuition:** Before February 1, 2012 – A \$500 non-refundable deposit per session is withheld.

After April 2, 2012 – a \$1000 non-refundable deposit per session is withheld. Providing another camper is secured to take your daughter's place, the remaining balance will be refunded. If her placement remains vacant all tuition and riding payments already paid are forfeited and any balance due is the responsibility of the girl's family.

**Riding Fees:** A non-refundable fee will be withheld for riding withdrawals made after February 1, 2012. (*Amount varies by program – please see financial information sheet.*)

**Late arrivals or early departures** – There is no reduction in tuition for late arrivals or early departures from camp for any reason. If, for any reason, your daughter does not complete her stay at Lochearn, her unused store deposit will be returned at the end of the season; her tuition and riding fees, however, are nonrefundable. Camp Lochearn, Inc. reserves the right to dismiss any camper due to inappropriate behavior including but not limited to use of tobacco, alcohol, or non-medically authorized drugs, self-destructive behavior, or behavior which is consistently disruptive to her cabin group and/or the general community. No refunds will be given if a child is dismissed from camp for inappropriate behavior.

## Other Important Considerations

**Late payments** – A late payment fee of 1½% per month will be assessed on all overdue balances.

**Non-payment of Fees** - If you fail to make payment for tuition, fees or other charges you are responsible to Camp Lochearn, Inc. for all costs of collection, including legal fees and late charges.

**Medical Care** – Medical care provided by Lochearn's in-house medical staff is included in the tuition. Parent grants Camp Lochearn, Inc. permission to utilize medical treatment (including general physician care, dental, orthodontic, optical care, hospital care) outside of camp should the camp's medical staff or Director deem such treatment necessary for the camper's well-being. Should it be necessary for the well-being of the camper to use outside medical care, all expenses involved will be paid by Parent. Accidents occurring during the camper's attendance at Lochearn will be paid by Lochearn Camp's accident policy up to accident insurance policy limits.

**Camper Medical Information** – Parent must inform the Director prior to registration if camper has received professional counseling or medication for behavioral modification during the last 12 months. Parents must also inform Director immediately if such care or medication occurs after registration and prior to the camp season. Failure to so inform Director may lead to dismissal of camper from Camp, and in the event of such dismissal, there will be no refund.

**Use of camp photographs and recordings** – During the course of the season and at other times of the year, Camp Lochearn, Inc. regularly takes photographs, makes slide shows and videotapes, and other types of recordings that are used for promoting Camp Lochearn. This is standard industry practice. My signature on the front of this form signifies that I consent to the use of photographs of my child or likenesses of my child by Camp Lochearn, Inc. or by anyone to whom they may assign such rights. Further, I release Camp Lochearn, Inc. or anyone to whom they may assign such rights from any claims arising out of the use of such photographs or likenesses of my child.

**Belongings** – Camp Lochearn, Inc. is not responsible for camper's belongings or equipment while in transit or at camp.

**Additional Expenses** – Costs for Lochearn provided transportation, special trips, events and programs, and purchases from the camp store are additional.
